I/We hereby agree to ratify and confirm all transactions, trade and dealings done by the AR with you. To the extent possible, I/we will not place orders or receive instructions directly with and / or from you while this authority is subsisting. However, in case of any contradictory instructions received by you from me/us, my/our instructions will prevail. Such full/accurate/proper communication/instructions between me/us and my/our AR shall always be my/our sole responsibility and I/We shall not hold KTCPL liable/responsible for any mis-communication/non-communication/short or inaccurate communication to you and the same shall not be the reason of dispute later on, for all or any transactions carried under the aforesaid trading account/client code.
 - I/We also undertake to honour all obligations arising out/by virtue of this authority letter and I/We indemnify and shall keep KTCPL indemnified from any and all costs, losses arising out of such orders.
